# Minutes of the Meeting of the Massachusetts College of Liberal Arts BOARD OF TRUSTEES ACADEMIC AFFAIRS COMMITTEE <br> Tuesday, March 22, 2016 <br> Bowman Hall, Room 217

The meeting was called to order at 8:58 a.m. The agenda is to review faculty personnel items including recommendations for tenure, promotion, and reappointment. Dean Joslin provided an evaluation and recommendation for all faculty put forth and Vice President Brown concurred with her recommendations.

## Tenure Recommendations

Vice President Brown presented background on the faculty seeking tenure. Under the MSCA Agreement faculty can apply early, though they must apply by their sixth year of service if in a tenure-track position. Three faculty being advanced today are seeking appointment a year early. This is allowable under the contract for those who make an exceptional contribution to the College or their discipline.

The committee reviewed the tenure recommendations for the following:

- Elizabeth "Liz" Hartung, Assistant Professor of Mathematics - Mathematics Department
- Laura Standley, Assistant Professor of Theatre - Fine and Performing Arts Department
- Nick Stroud, Assistant Professor of Education - Education Department
- Benjamin "Ben" Wood, Assistant Professor of Psychology - Psychology Department

Professors Hartung, Stroud, and Wood are seeking tenure one year early. The Committee on Tenure, the respective Department Chairs, and the Vice President and Dean of Academic Affairs all agree that they have made exceptional contributions as required for an early appointment.

Upon a motion duly made and seconded, it was

VOTED unanimously to recommend tenure for Elizabeth Hartung, Laura Standley, Nick Stroud, and Benjamin Wood.

Trustee Chamberlain suggested that these faculty members be invited to the April 7 Board meeting at which time the full Board will vote to approve the recommendation of the Academic Affairs Committee for tenure.

## Promotions

As with tenure, promotion recommendations are based on a portfolio review conducted by the Committee on Promotion, separate from the Committee on Tenure. Promotion does not require a vote by the Board of Trustees.

Each promotional rank has a requirement regarding level of education and years of experience. Three faculty are applying early for promotion under the exceptional clause. They are Professors Hartung, Stroud, and Wood.

Dean Joslin has recommended and Vice President Brown has approved the following faculty for promotion:

## Reappointments

Through the annual reappointment process faculty are evaluated through a full portfolio of work along with evaluations during their second and fourth years of service. In the third and fifth years department Chairs provide evaluations along with student evaluations (SIRII). Reappointment does not require a vote by the Board of Trustees.
